MANAGEMENT QUOTA ADMISSION COUNSELLING: MAIT & BPIT

The two affiliated institutes Maharaja Agrasen Institute of Technology (MAIT) and Bhagwan Parshuram Institute of Technology (BPIT) have sent email today late in evening forwarding the copy of schedule of counselling dated 10.11.2022 for admissions in Management Quota Seats in B.Tech Programme for 2022-23 in their Institutes The schedule of counselling received from both the Institutes is enclosed along with this Notice and certain details regarding admission counselling process is also stated in brief below

Maharaja Agrasen Institute of Technology (MAIT) vide there Circular no. MAIT/MQ-ADM/2022/NOV 22 dated 10 November 2022 (received from MAIT through email late in evening) have forwarded the schedule of counselling for admission in Management Quota seats 2022-23 in B.Tech programme CET-131

Bhargwan Parshuram Institute of Technology (BPIT) vide there Notice no. F.1/BPIT/MQ-Counselling/B.Tech/2022/1521 dated 10 November 2022 (received from BPIT through email late in evening) have forwarded the schedule of counselling for admission in Management Quota seats 2022-23 in B.Tech programme CET-131

As per the circular MAIT/MQ-ADM/2022/NOV 22 dated 10 November 2022 and Notice no. F.1/BPIT/MQ-Counselling/B.Tech/2022/1521 dated 10 November 2022 the 1st round of counselling for Management Quota seats in respect of both the **affiliated college MAIT and BPIT shall commence with effect from 11.11.2022**

The copy of circular no MAIT/MQ-ADM/2022/NOV 22 dated 10 November 2022 and Notice no. F.1/BPIT/MQ-Counselling/B.Tech/2022/1521 dated 10 November 2022 are enclosed along with this notice of the University for information of all 849 candidates who have registered on the University portal for participation in the admission process of Management Quota seats

It is for information of all candidates and both the concerned Affiliated Institute that the reserved Management Quota seats if not filled during the first round of counselling on 11 November 2022 will only be converted into unreserved category during the second round of counselling of Management Quota seats.

It is once again clarified that the reserved category Management Quota seats if unfilled on first day shall not be converted into unreserved during the first round of counselling under any circumstances.


It is for information of candidates that though the institute MAIT in the schedule of counselling have directed for payment of the academic fee through Pay Order or DD payable at Delhi in favour of Maharaja Agrasen Institute of Technology however the candidates are hereby informed that those candidates who wish to make payment through digital mode may inform the institute MAIT. The institute MAIT is being issued separate instructions not to refuse acceptance of academic fee from the candidates who are not carrying DD or Pay order and therefore wish to make their payment through Digital Mode

The Institute BPIT has already made provisions for online payment of academic fee in their counselling schedule.

The candidates not in position of original certificates of the qualifying examination and the marksheets but in position of authentic photocopy can submit the undertaking to the institute that the original certificates and the marsheet of the qualifying examination shall be submitted within a define period. The institute shall not deny admission in the Management Quota seats to a candidate who is in merit

and is willing to pay the academic fee as required merely on the pretext that the candidate is not in position of original documents at the time of counselling.

The remaining instructions as issued for admission in the Management Quota seats by the University in earlier orders shall remain the same and all the 849 candidates who have applied for admission in Management seats on University portal vide no. F.No. IPU-7/Online Counselling/2022/2964 dated 02.11.2022 are eligible to participate in the counselling for admission in Management Quota seats in B.Tech Programme during 2022-23.



Important Points to be Noted:

1. All Reserved category (SC/ST/DEF/PH) candidates of Delhi/Outside Delhi region shall present physically along with the desired documents for verification as per the date and time mentioned above.
2. Only Candidates with **NOT Admitted Status** are eligible to take part in the Counselling for management quota. (Not admitted means a candidate who has not taken admission in any of the Institutes affiliated to GGSIPU nor in University Schools of GGSIPU) or admitted under Management Quota. **Original admit card JEE is mandatory.**
3. Candidate shall submit an affidavit / undertaking on e-stamp paper (Rs. 10/-) that he/she has not taken admission and will not seek admission anywhere else in any of the college affiliated to GGSIP University once the seat is allotted under Management Quota.
4. Candidate who has already taken admission through online counselling or under Management Quota in any of the Institutes affiliated to GGSIPU shall not be eligible for consideration of seat allotment under Management Quota.
5. Candidates once admitted under Management Quota seat will not be eligible to take admission in any other college affiliated to GGSIPU.
6. The student to whom seat is allotted during the counselling must present original documents (for cross verification) along with two set of self-attested copies (to be deposited in the Institute).
7. The management quota seats will be filled up on the merit basis derived from the aggregate percentage scored in the qualifying examination/ preference of the course or program opted by the candidate.
8. Admission is confirmed only after the submission of the Institute fees in full by the candidate.
9. The entire session of Counselling/Admission will be video graphed.
10. Candidates will be called strictly on merit of the qualifying examination based on the Aggregate percentage of Class 12th.
11. Seat Matrix for Management Seats for B Tech Programmes Code-131) is also attached.
12. In the inter-se-merit of candidates securing equal aggregate percentage in class 12th, following criteria will be adopted to determine the merit:
 - (i) In case of candidates securing equal aggregate percentage, then the candidate getting higher marks in Mathematics of the qualifying examination;
 - (ii) In case of tie in (i) above, the candidate getting higher marks in Physics of the qualifying examination;
 - (iii) In case of tie in (i) and (ii) above, the candidate getting higher marks in Chemistry of the qualifying examination;
 - (iv) In case of tie in (i), (ii) and (iii) above, the candidate older in age shall rank higher.
13. Classes for 1st year students of B.Tech. Programmes have already been commenced from 7th November 2022 as per the Academic Calendar notified by the University wide Ref. No. GGSIPU/DAA/2022/4388 of October 31, 2022.
14. All admissions are provisional subject to the ratification by the University.
15. For further notification/s, applicants are advised to visit regularly the Institute website www.mait.ac.in.
16. Institute fees once submitted after accepting the seat under management quota will not be refunded.

Candidates shall bring the following documents in Original along with two self-attested copies for verification/deposition in the Institute

- i. Proof of registration/application submitted for Management Quote Seat applied on GGSIP University portal/Institute.
- ii. JEE Main Paper-1 of 2022 Admit Card (Original & Photocopy).
- iii. Copy of Rank obtained in JEE Main Paper-1 of 2022.
- iv. Original Certificates and Mark sheets of qualifying examination along with two sets of self-attested photocopies.
- v. Reserved category candidates shall bring original reserved category certificates along with two sets of self-attested photocopies.
- vi. Admission Verification Form (Appendix-6 of GGSIP University Admission Brochure).
- vii. Physical Fitness Certificate. All students shall be required to submit a Medical Certificate as given in Part-8 in Admission Brochure 2022 (As per Appendix 5).
- viii. Undertaking by the student with respect to anti-ragging and undertaking by parent/guardian with respect to anti ragging as per Appendix 7 & 8 of Admission Brochure for Academic Session 2022 -23 available on the university website.
- ix. Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer (Original), not more than 6 (six) months old.
- x. Six Recent Photographs (Size 1.5 Inch X 2 Inch) In Coloured Showing Front View of Full Face with White Background is Required (Black & White Photograph with Colour or Dark Glasses Dark Background, Polaroid Prints or Computer Prints will Not Be Accepted)
- xi. Copy of Aadhar and PAN card
- xii. In case of gap year, the candidate is also required to submit a notarized Gap Year Affidavit on stamp paper of Rupees Ten along with one self-attested photocopy.
- xiii. Candidate shall submit an **affidavit** on stamp paper of Rupees Ten that he/she has not taken admission and will not seek admission anywhere else in any of the college affiliated to GGSIP University once the seat is allotted under Management Quota.
 - a) Candidates who has already taken admission through online counselling shall not be eligible for consideration under M.Q seats.
 - b) Candidates once admitted under Management Quota seat will not be eligible to take admission in any other college affiliated to GGSIPU.
- xvi. The academic fee of Rs. 1,65,200/- for B.Tech student for the academic session 2022-23 through Pay Order / DD payable at Delhi in favour of Maharaja Agrasen Institute of Technology (additional fees will be charged from the student's subject to revision of the fees as per Department of Higher Education , Govt. of Delhi /GGSIPU if any). (No cash payment will be accepted)


Important Instructions:-

- 1) The candidates must read the conditions of eligibility as given in the Admission Brochure 2022-23 and other Notifications issued by GGSIP University for admission in B.Tech Programme under management quota and must satisfy themselves regarding their eligibility.
- 2) Only those candidates, who registered themselves on GGSIP University's portal & whose name appear in the Merit list provided by the University, can participate in the counseling for admission in B.Tech Programme under Management Quota category.
- 3) The counseling shall commence in the Institute Campus at 9:30 AM sharp. Therefore, all the desirous participating candidates must report in the Institute before the designated time. Latecomers will not be allowed to participate in counseling.
- 4) Those candidates seeking admission against the reserved categories have to produce the original caste certificate issued by the competent authority of Govt. of NCT of Delhi besides, an Undertaking in the format given in Appendix 10 of Admission Brochure 2022-23 at the time of counseling.
- 5) For claiming reservation on a seat reserved for Defense Category, the candidate have to produce duly signed Appendix-I of Admission Brochure 2022-23 by the competent authority as mentioned in Admission Brochure 2022-23.

- 6) All the reserved seats, that remain vacant after completion of the first round of counseling, shall be converted into unreserved /general category of seats and will be filled up out of general category of candidates in the second round of counseling.
- 7) Those candidate who are admitted in the first or second counseling will be required to deposit the annual fee amounting Rs, 1,69,200/- (Rupees one lac sixty nine thousand two hundred only) instantly either by way of Bank Draft drawn in favour of BPIT or online through BPIT website using the tab "New student fees" (online mode) by 3:00 PM positively. Those candidates, who fail to deposit their fee on the same day, their admission shall stand cancelled.
- 8) If any candidate seeks withdrawal of his/her admission, his or her request for withdrawal of admission should reach the Principal BPIT by 11-11-2022 at 3:00 PM in the format as given in Appendix-11 of Admission Brochure 2022-23.

 - xii. Candidate who has already taken admission through online counseling shall not be eligible for consideration under M.Q Seats.
 - xiii. Candidates once admitted under Management Quota seat will not be eligible to take admission in any other college affiliated to GGSIPU.
 - xiv. All admissions are provisional subject to ratification by the university.
 - xv. Seat Matrix for Management Seats for B.Tech Programmes (Code-131) is also attached.
 - xvi. Classes for 1st year students of B.Tech programmes have commenced from 7th November 2022, as per the Academic Calendar notified by the University.

N.B.

1. Candidates will be called strictly on merit of the qualifying examination based on aggregate marks percentage. If aggregate marks scored by two or more candidates are same then merit is decided on the maximum marks in Mathematics. If still there is a tie then candidate having more marks in Physics will get higher rank. If marks in all three subjects are same then merit will be decided on Date of Birth (older in age shall rank higher).
2. Admission is Confirmed only when full fee is deposited.
3. The entire session shall be video graphed.
