IMPORTANT NOTICE

Subject: Result awaited cases for Engineering, B.Arch and Professional programmes (except NEET based admissions).

1. This has reference to para 1 (i & ii) of clause 3.5 of Chapter 3 of Admission Brochure 2020-21 the contents of which are reproduced as under:

Result Awaited / Compartment / Supplementary Cases

- i. All such candidates who have appeared in the qualifying examination (irrespective of the outcome of their final result) will be eligible to appear in the CET 2020-21 and all such candidates will be provisionally admitted in the respective programmes;
- ii. The candidate will have to submit the final result of qualifying degree proving his/her eligibility on or before 30° September 2020 to their concerned Dean/Principal/Director of their respective School/College/Institute where the admission has been granted provisionally. The concerned Dean/Principal/Director must submit the details of these result provisionally admitted students within 7 days i.e. 7° October 2020 to Joint Registrar (Admissions), GGSIPU, 16 C Dwarka, New Delhi 110078. In case the candidate fails to submit his/her final result of qualifying degree in the manner as prescribed above to prove his/her eligibility on or before 30 th September, 2020, whatsoever, the reason may be, his/her admission will be treated as null and void (cancelled) and the entire fee will be forfeited and under no any circumstances he/she will be allowed to appear in the End Term Exam. No extension beyond 30° September, 2020 shall be allowed by the University in any case. The Dean/Director/Principal will be responsible to ensure that the eligibility of all students are checked by them to ensure correctness of admissions specially incase of provisional students. The provisional admission will automatically stand cancelled if the candidates fails to submit result in time i.e. 30 th September, 2020
- 2. However, due to Covid 19 and other circumstances, prevailing upon, there is delay in declaration of results and it is not feasible for the candidates to meet the deadline / stipulated last date of proving his / her eligibility on or before 30th September 2020 as given in the Admission Brochure 2020-21.

Accordingly, it is brought to the notice / information of all such candidates / stakeholders that the last date of submitting the final result of qualifying degree

proving his / her eligibility may be read as 31st December 2020 instead of 30th September 2020. The concerned Deans / Principal / Director must submit the details of these result provisionally admitted students within 07 days i.e. January 07th, 2021 to the Joint Registrar (Admissions), GGSIPU, Sector-16, Dwarka, New Delhi-110078. The other content of the clause 3.5 of Chapter 3 of Admission Brochure 2020-21 remains the same and shall be strictly complied with without any relaxation. No extension beyond December 31st 2020 shall be allowed by the University in any case.
