**ALL THE CANDIDATES MAY KINDLY NOTE THE FOLLOWING INFORMATION ALSO FOR THE MOP UP ROUND ADMISSIONS THAT:**

- 1. IT IS ONCE AGAIN REITERATED THAT ANY CANDIDATE WHO HAS JOINED THE COLLEGE PURSUANT TO ALLOTMENT OF SEAT IN ROUND 01 OR 02 AND HIS/HER NAME EXISTS IN THE LIST OF JOINED/REPORTED CANDIDATES IN THE COLLEGE AFTER ROUND 02, THEN HE/SHE SHALL NOT BE ELIGIBLE TO PARTICIPATE IN THE MOP UP ROUND.**

**SUCH CANDIDATES WHOSE NAME EXISTS IN THE LIST OF JOINED/REPORTED CANDIDATES IN ANY MEDICAL COLLEGE AFTER ROUND 02, THEN THEREAFTER SUBSEQUENTLY WITHDRAWS HIS/HER ADMISSION, SUCH CANDIDATES SHALL ALSO NOT BE PERMITTED TO PARTICIPATE IN THE MOP UP ROUND.**

**CONCEALMENT OF INFORMATION BY THE CANDIDATES AT THE TIME OF MOP UP ROUND REGARDING HAVING WITHDRAWN ADMISSION AFTER JOINING OR REPORTING AFTER ROUND 02 SHALL AUTOMATICALLY RESULT IN CANCELLATION OF ADMISSION WHENEVER SUCH CONCEALMENT IS DETECTED.**

**THE CANDIDATES ARE ADVISED TO READ RELEVANT GOVERNMENT OF INDIA GAZETTE NOTIFICATION REGARDING ELIGIBILITY TO PARTICIPATE BY CANDIDATES IN MOP UP ROUND TO AVOID INCONVENIENCE AND OTHER DIFFICULTIES AT LATER STAGE.**


