DETAILED SCHEDULE FOR OFFLINE COUNSELLING OF STRAY VACANCY ROUND FOR
MBBS (2020-21)

Subject: Conduct of Offline Counselling for Stray Vacancy Round to be held on 12.01.2021 for admission in MBBS programme in the respect of the following Medical Colleges affiliated with Guru Gobind Singh Indraprastha University, New Delhi:

- (i) North DMC Medical College & Hindu Rao Hospital – NDMC (MC), Hindu Rao Hospital, Malkaganj, New Delhi
- (ii) Dr. Baba Saheb Ambedkar Medical College and Hospital, Sector 6, Rohini, Delhi
- (iii) Army College of Medical Sciences, Near Base Hospital, Delhi Cantt., New Delhi.

The Candidate must read the schedule carefully.

→ ADMISSIONS WILL BE MADE ON "NEET ALL INDIA RANK"

→ The Candidates who did not register are not eligible for Counselling.

This is in continuation to University's Notification under above reference. The NEET UG 2020 qualified candidates, who have registered with GGSIPU and have not been allotted any seat through any rounds of the State/AIQ/Deemed University Counselling across the country, are eligible to appear in the Stray Vacancy Round of State Counseling process for MBBS programme for Verification of Documents and Allotment of Seats at the venue of counselling in person, on the date and time mentioned in the succeeding paras, as per their Category and Rank.

1. **SEAT MATRIX:** The number of seats to be filled up through GGSIP University in the Stray Vacancy Round of counseling in respect of the 03 medical colleges stated above, shall be displayed before the commencement of the counselling at the counseling venue. The following vacancies are on account of vacant seats after Mop Up Round of counseling and Not Reported candidates after allotment in Mop Up Round, (category wise) is detailed below:

2. Candidate, who wishes to claim seat in **Delhi Region category**, then he/she must bring proof of having passed 11th & 12th standard exam (under 10+2 scheme) from any school located in Delhi.

3. *For Eligibility, Documents required at the time of counselling, Fees, Age Bar, Age Relaxation please refer to the earlier notifications / schedules and Admission Brochure 2020 of GGSIPU.*

The Stray Vacancy Round of Counselling will commence from 'NEET UG 2020 ALL INDIA RANK 01' onwards for all available vacant categories and the seats will be allotted strictly on the basis of merit. The candidates who were absent in the previous rounds of counselling or have not been allotted a seat in any rounds of counselling, will be permitted to attend this round of counselling. Admission will be made strictly on merit basis and the counselling / admissions will stop when all the seats get filled up. **Parents / candidates are advised to check University's website for notices before coming for counselling to avoid any inconvenience.**

Notes:

- (a) If any vacancy sub-categories (i.e. Defence and PWD/PH) exist and the same remains vacant, then they shall first be reverted to that respective parent category.
- (b) Thereafter, the conversion of SC, ST, OBC to General Category shall be done only during the counselling. While converting the seats in Extended round, any unfilled seat reserved for ST category will be offered to SC category and vice versa and only after completing this exercise, the conversion of the reserved category seats to General Category shall be effected. However, any OBC vacant seat shall be directly converted to General Category.
- (c) Any, PH/SC/ST vacant seat in ACMS, the same shall be converted to the seats for 'Wards of Army Personnel' after exhausting the complete list of that particular category.
- (d) All the candidates claiming seats in **Defence Priority (I to IX)** shall visit the University on the notified date and time. The University will call candidates **priority wise** for verification of documents and allotment of seats within the notified date and time.
- (e) Candidates are requested to refer to the tentative seats available for Stray Vacancy Round Counselling at the counseling venue. All the candidates have been called accordingly to ensure that no seat remains vacant. However, the counselling shall stop as and when the seats are filled up.
- (f) Any category candidate, which have not been called and/or whose vacancy does not depict in the 'vacancy position' may attend the counselling as an unreserved category candidate and/or the vacancy may arise consequent to the conversion of categories.
- g) **CUT-OFF percentile and score as per MCI Regulation shall be applicable.**

- ⇒ Counselling for the seats reserved for any Region / Category (if any vacancy arises other than mentioned above) shall be stopped as and when the seats in / of such Category / Region are filled up. Candidates / parents are requested to regularly visit the University website www.ipu.ac.in and <https://ipu.admissions.nic.in> for updates.

5. ELIGIBILITY FOR PARTICIPATION AND ALLOTMENT OF SEAT IN MBBS STRAY VACANCY ROUND:

- Candidates who have registered online with GGSIPU and have submitted the Online counselling participation fee of Rs. 1000/- and have never been allotted a seat through any rounds of State/AIQ/Deemed counselling.
- All the reported candidates at the end of Extended 2nd Round & Mop-Up Round of Counselling in the affiliated medical colleges of GGSIPU will not be eligible for any category or seat Up-gradation.
- The candidates who have taken withdrawal after Extended 2nd Round & Mop-Up Round of Counselling after reporting at their allotted college/institute will not be eligible.
- The following categories of candidates are NOT ELIGIBLE to participate in this round:
 - Candidates who joined the allotted seat in Round II of State/AIQ/ Deemed/ Central Universities across the country.
 - Candidates who joined the allotted seat in Round II of State/AIQ/ Deemed/ Central Universities across the country and subsequently withdrawn.



iii) Candidates allotted a seat in Mop Up Round of State/AIQ/ Deemed/ Central Universities across the country.

iv) Candidates allotted a seat in Mop Up Round and NOT REPORTED.

v) Candidates joined the allotted seat in Mop Up Round.

vi) Candidates joined the allotted seat in Mop Up Round and subsequently withdrawn.

vii) Candidates who have not registered with GGSIPU.

e) Only Fresh Allotment will be done according to the Merit of the candidates and seat matrix available category-wise.

f) Candidates who are registered with GGSIPU have joined their allotted college after Round 02 of allotment through AIQ/Deemed/any State across the country, will not be eligible. Such candidates have been debarred from participation in the counselling.

g) Physical presence of Candidates along with original documents is must at the time of verification of documents and allotment of seat.

6. **FEES TO BE PAID AT THE TIME OF COUNSELLING/ALLOTMENT OF SEAT** in the University, a candidate will mandatorily bring a Demand Draft of Rs. 40000/- in the name of **REGISTRAR, GURU GOBIND SINGH INDRAPRASTHA UNIVERSITY**, payable at **DELHI**. Balance fees, if any, shall be paid by the candidate directly in the respective allotted college.

All the candidates are advised to get their Demand Draft prepared and complete their documents well before the counselling dates to avoid any inconvenience.

7. **DATE AND TIME FOR REPORTING/JOINING THE ALLOTTED COLLEGE:**

All the candidates admitted in the Stray Vacancy Round of Counselling conducted by GGSIPU, shall report/join in the allotted college, by **15th JANUARY 2021**.

8. **GENERAL TERMS AND CONDITIONS FOR ADMISSION / COUNSELLING:**

i) **Clarification of Scheduled Caste Category Certificate.** It is seen that some SC category certificates issued by competent authority of NCT of Delhi has a clause stating that this certificate is issued on the basis of certificate of parent issued by competent authority of a State / UT other than NCT of Delhi.

The benefit of reservation shall also be extended to all candidates who hold SC certificates issued from GNCTD provided such caste is enlisted in the list of Scheduled Caste as specified in Presidential Order 1951 as amended from time to time in respect of Delhi subject to fulfillment of other conditions specified therein.

Such candidates whose certificate has been issued by competent authority in GNCTD but their castes do not fall in Delhi, as specified in the Presidential Order 1951 shall not be considered for admission against seats reserved for 'Delhi Region Category'. However, they may be considered in 'All India Region Category' as per their merit purely.

ii) **Clarification on Other Backward Class Certificates.** Same as above, a certificate issued by a competent authority of Delhi on the basis of caste certificates of his/her parents from another State, will be accepted for claiming seat in OBC category if and only if the caste is in the list of notified OBC list by Govt of NCT of Delhi for claiming benefit of 'Delhi Region OBC'. **THE NON-CREAMY LAYER CERTIFICATE SHOULD BE ISSUED AFTER 31.03.2020.**

The reservation certificate should be in the name of the candidate seeking admission. The reservation certificate in the name either of parents (Father/Mother) is not acceptable. The name and other particulars in the reservation certificate should be identical to that in registration form as well as in the 10th & 12th class certificates. Any variation in the name or other particulars in reserved category certificate may lead to refusal for admission by admission officer in the reserved category. In absence of

reserved category certificate, the candidate will not be entitled for any provisional admission in reserved category on the basis of any undertaking.

The required certificate(s) for reserved categories/classes will be essential at the time of the counselling/admission and no provisional admission shall be admissible for want of caste/category certificate. Further, the caste/category certificate should invariably be in the name of the candidate himself/herself and not in favour of respective parents/guardians.

9. For admission to North Delhi Municipal Corporation (Medical College) Hindu Rao Hospital, Dr Baba Saheb Ambedkar Medical College & Hospital, only the candidates who have studied 10+2 (11th and 12th class) in the recognized School located in Delhi only and passed the qualifying examination from any school located in Delhi only shall be eligible for admissions. The admission to the ACMS in 'ARMY' Category is for the children of eligible serving Army Personnel, Ex Army Personnel and War Widows/Widows of the Army. The children of various categories of Army personnel are eligible and they are required to submit the relevant certificate as given against the category applicable to them as proof of their eligibility for admission to ACMS at time of Counselling/Admission.

10. **Eligibility Condition for MBBS programme:** Candidate must have passed in the subject of Physics, Chemistry, Biology/Biotechnology and English (Core or Elective or Functional) individually and must have obtained a minimum of 50% marks together in Physics, Chemistry, Biology /Biotechnology and English (40% in case of SC/ST/OBC candidate, subject to availability of seat for these categories in the respective institutions). All candidates must appear in National Eligibility cum Entrance Test – Undergraduate of 2020 (NEET UG 2020) and qualify to be considered for admissions.

11. **Age Limit and Age Relaxation:** Refer Admission Brochure 2020-21.

12. **DOCUMENTS REQUIRED AT THE TIME OF COUNSELLING / ADMISSIONS:**

- i) Copy of GGSIPU Online Registration Form
- ii) Four passport size photographs
- iii) Demand Draft(s) of Requisite Fee in favour of Registrar, Guru Gobind Singh Indraprastha University payable at Delhi. Details are mentioned below. Write the name of the candidate, name of the programme on the back of Demand Draft (s).
- iv) Copy of Admission verification form (duly filled by candidate as per Appendix 4(B) given in Admission Brochure 2020-21.
- v) Preference Sheet (duly filled by candidate as per Appendix 7 given in Admission Brochure 2020-21.
- vi) Matriculation/High School/Higher Secondary Certificate for verification of date of birth;
- vii) Certificate and Marksheets of the qualifying examination (11th & 12th both) issued by the Board/University.
- viii) Character Certificate from the head of the Institution from where the qualifying examination was passed or from Gazetted Officer (not more than 6 months old).
- ix) SC/ST/OBC/DEF/PWD/EWS etc. Certificate, if applicable (Original and One Photocopy).
- x) Appendix 1, Admission Brochure 2020-21 along with the relevant entitled certificates, if admission is claimed in Defence Category.
- xi) Relevant Appendix (as mentioned in the Admission Brochure 2020-21) for claiming reservation in 'ARMY' Category.
- xii) Medical Certificate (as per Appendix 6, Admission Brochure 2020-21).
- xiii) The candidate has to be present in person for the purpose of verification of documents and allotment of seats as the schedule.
- xiv) The candidate must produce original certificate for the purpose of verification of documents and allotment of seats and in case he has taken admission somewhere else in programme other than MBBS and deposited the documents, then he/she should submit a written proof from the concerned college/institution/ university for the same.


13. **Important Note:**

- a. The admission of students, who fail to fulfill the minimum eligibility criteria mentioned in the Admission Brochure or as stated by the Statutory Body or fail to produce the adequate documents for eligibility and reservation, will be cancelled.

- b. The allotment of seat of a candidate will also be cancelled, if the candidate already holds a seat in by allotment through any rounds of any State/AIQ/Deemed across the country during the session 2020-21.

Any other terms and conditions as defined by the Statutory body/Competent Authority, shall be applicable for counseling process/admission to MBBS programme for academic session 2020-21.
