

Candidates are requested to please refer to the '**SCHEDULE FOR OFFLINE COUNSELLING OF STRAY VACANCY ROUND FOR MBBS (2020-21)**' already uploaded on the University website vide notification no. 232/2020 dated 06.01.2021 for instructions related to fulfillment of Eligibility, Demand Draft and Documents to produce at the counselling venue.

The candidates are also requested to acquaint themselves with the provisions of Admission Brochure and various statutory authorities and the Gazette notification of MCI, Govt. of India.

2. All the GGSIPU registered candidates who have qualified NEET UG 2020, have passed their 11<sup>th</sup> and 12<sup>th</sup> Class from any school located in Delhi, have a valid OBC certificate and have not been allotted any seat through any rounds of counseling either through All India/ State Quota/Deemed University across the country) are eligible to participate in this counselling. The seat shall be allotted purely on merit and the counselling shall stop as and when the seat is filled up.

**Clarification on Other Backward Class Certificates.** A certificate issued by a competent authority of Delhi, will be accepted for claiming seat in OBC category if and only if the caste is in the list of notified OBC list by Govt. of NCT of Delhi for claiming benefit of 'Delhi Region OBC'. **THE NON-CREAMY LAYER CERTIFICATE SHOULD BE ISSUED AFTER 31.03.2020.**
