Subject: Result awaited cases for Engineering, Professional programmes (except B.Arch and NEET based admissions).

GGSIPU/J.R (Admissions)/2020-21/566 dated 19.10.2020 (available on the University website (i.e.www.ipu.ac.in & <a href="https://www.ipu.admissions.nic.in">www.ipu.admissions.nic.in</a>) on the subject, cited above.

In continuation of the above referred notices, it is brought to the notice / information of all such candidates / stakeholders that the last date of submitting the final result of qualifying degree proving his / her eligibility has been further extended upto 28<sup>th</sup> February 2021.

The concerned Deans / Principal / Directors to ensure mechanism to monitor the cases of such candidates admitted provisionally to ensure that the candidates are informed prior to 28<sup>th</sup> February 2021 that failure to submit the result by 28.02.2021 shall result in cancellation of their provisional admission. Deans / Principal / Directors will submit the list of all such candidates by March 03<sup>rd</sup>, 2021 who have failed to submit the proof of eligibility by 28<sup>th</sup> February, 2021 and also certify that such candidates have been denied permission to attend the classes. In case, the candidate fails to submit his/her final result of qualifying degree in the manner as prescribed above to prove his / her eligibility on or before 28<sup>th</sup> February 2021 whatsoever, the reason may be, his/her admission will be treated as null and void (cancelled) and the entire fee will be forfeited and under no any circumstances he / she will be allowed to appear in the End Term Exam.
