Candidates are advised to refer the Advisory for all State Counselling authorities & State DMEs uploaded by the O/o ADG (ME), DGHS, Govt. of India via notification ref. U-12021/06/2021-MEC dated 12-02-2022.

Candidates are advised to refer the judgement of the Hon'ble Supreme Court of India in Transferred Case (Civil) No. 98 OF 2012 titled "Christian Medical College Vellore Association vs. Union of India and Others and also to the Sub-Point 5, Appendix 'F' of the Medical Council of India Regulations on Graduate Medical Education, 1997 (Amended upto May, 2018) published in The Gazette of India vide notification no. MCI-34(41)/2018-Med./109835 dated 18<sup>th</sup> May, 2018 which relates to the Matrix that shall be applicable with regard to permissibility to students to exercise fresh choice during counselling.

The University shall conduct the Round II Offline Counselling for admission in MBBS on the basis of merit from among the NEET UG 2021 qualified candidates who have registered with the GGSIP university.

Tentative list of registered applicants annexed with the notification may please be referred only and only for the purpose of ascertaining the merit for allotment of seat in Round II offline counselling. However, the final merit shall be ascertained at the time of counselling/allotment of seat.

This schedule contains the date and the time for allotment of seats and reporting of candidates in the order of merit for verification of documents as well as verification of eligibility and thereafter for allotment of the seats.

The candidate shall have the right to exercise the choice of his/her college at his/her rank subject to availability of the seat in his/her category.

The University shall declare closure of the Round II Offline Counselling as and when all the vacant seats are filled up in order of merit from among the reported candidates.

The candidates shall fill up the fresh preference sheet during the process of offline counselling and the choices filled during online counselling shall be treated as null and void.

Any change in reservation policy, if taken by the Government of India/NCT of Delhi or the University, the counselling will be conducted in accordance to that.

All counseling shall be held according to the directions of the statutory regulatory body, Govt. of India, Govt. of NCT of Delhi, Hon'ble Court(s) and/or the University.

**IMPORTANT NOTE: ALL THE CONCERNED CANDIDATES ARE ADVISED TO STRICTLY ADHERE TO THE BELOW INSTRUCTIONS.**

- i) The admissions/allotment of seat shall be based only on the merit of NEET UG 2021 from among the students whose names are appearing in the attached tentative registered list subject to verification of documents to ascertain eligibility for allotment of seat as per the regulations of the University/Statutory Body.
- ii) It is mandatory for all the candidates to attend the counselling in person at the University Dwarka Campus along with their original documents and photocopies (for retaining in file).
- iii) Candidates essentially shall produce the original certificates at the time of counselling/allotment of seat and in case he/she has taken admission somewhere else in programme other than MBBS and deposited the documents, then he/she should submit a written proof from the concerned college/institution/ university for the same. However, the seat allotment shall be as per the matrix of MCI regarding the eligibility to participate in further rounds of counselling.
- iv) Candidates shall be submitting an undertaking of not having admitted / joined any seat in MBBS consequent to the conduct of 2<sup>nd</sup> Counselling through AIQ/Deemed/or any other State Counselling etc. and such candidates shall not be granted any seat in this round of counselling. In the event, the candidate undertaking or any other document is found to be false, the admission of candidate shall be cancelled at that stage of the programme.
- v) Candidates admitted through this Counselling shall join in their allotted college on 21<sup>st</sup> & 22<sup>nd</sup> March, 2022 latest by 4.00 PM, failing which, they shall have no claim on the allotted seats and their admission shall be treated as cancelled.
- vi) Number of tentative seats available for Round II Offline Counselling is already uploaded on the University website vide notification no. 136/2021 dated 21.02.2022. The final category wise vacant seat status shall be displayed/announced at the counselling venue.

2. **ELIGIBILITY FOR PARTICIPATION AND ALLOTMENT OF SEAT IN MBBS ROUND II:**

- Candidates who have registered online with GGSIPU, paid non-refundable Registration fee of Rs. 1200/- and have also submitted the non-refundable Counselling Participation Fee of Rs. 1000/-.
- All the reported candidates at the end of Round I of Counselling in the affiliated medical colleges of GGSIPU will be eligible for seat Up-gradation. Such candidates need to submit their Provisional Allotment Letter/Reporting Slip at the Counselling venue. Once upgraded, they shall not have any claim on their previously allotted seat and the same shall be offered to the next in merit candidate/applicant.
- The candidates who have taken withdrawal after Round I after reporting at their allotted college/institute will be eligible. However, they shall claim only on the available seats at the time of counselling for Round II.
- Allotment will be done according to the Merit of the candidates and seat matrix available category-wise.
- Candidates registered with GGSIPU and have joined their allotted college after Round 02 of allotment through AIQ/Deemed/any State across the country, will not be eligible for this round of counselling being conducted by GGSIP University. Such candidates shall be debarred from participation in the counselling. A list of such admitted applicants/candidates has been uploaded by the Medical Counselling Committee on its website.
- All other candidates (registered with GGSIPU for participation and allotment of seat in MBBS program) who are not holding any seat through any rounds of AIQ/Deemed/State Counselling till now will be eligible to participate in this round. This includes:
