AND ALLOTMENT OF SEAT IN THE MOP UP ROUND COUNSELLING SHALL BE ASCERTAINED AT THE COUNSELLING VENUE BEFORE ALLOTMENT OF SEATS.

THE CANDIDATE SHALL HAVE THE RIGHT TO EXERCISE THE CHOICE AT HIS/HER RANK SUBJECT TO AVAILABILITY OF THE SEAT IN HIS/HER CATEGORY.

THE UNIVERSITY SHALL DECLARE CLOSURE OF THE MOP UP ROUND COUNSELLING AS AND WHEN ALL THE VACANT SEATS ARE FILLED UP IN ORDER OF MERIT FROM AMONG THE REPORTED CANDIDATES.

IMPORTANT NOTE: ALL THE CONCERNED CANDIDATES ARE ADVISED TO STRICTLY ADHERE TO THE BELOW INSTRUCTIONS.

- i) The admissions/allotment of seat shall be based only on the merit of NEET UG 2021 from among the registered students subject to verification of documents and fulfilment of eligibility for allotment of seat as per the regulations of the University/Statutory Body.
- ii) It is mandatory for all the candidates to attend the counselling in person at the University Dwarka Campus along with their original documents and photocopies (for retaining in file).
- iii) Candidates essentially shall produce the original certificates at the time of counselling/allotment of seat and in case he/she has taken admission somewhere else in programme other than BAMS/BHMS and deposited the documents, then he/she should submit a written proof from the concerned college/institution/ university for the same. However, the seat allotment shall be as per the norms of AYUSH regarding the eligibility to participate in counselling.
- iv) Candidates shall be submitting an undertaking of not having admitted / joined any seat in BAMS/BHMS consequent to the conduct of Counsellings through AIQ/Deemed/or any other State Counselling etc. and such candidates shall not be granted any seat in this round of counselling. In the event, the candidate undertaking or any other document is found to be false, the admission of candidate shall be cancelled at that stage of the programme.
- v) Candidates admitted through this Counselling shall join in their allotted college till 27th April, 2022, failing which, they shall have no claim on the allotted seats and their admission shall be treated as cancelled.
- vi) Number of tentative seats available for Mop Round Offline Counselling is already detailed above. The final category wise vacant seat status shall be displayed/announced at the counselling venue.

- (a) If any vacancy sub-categories (i.e. Defence and PWD/PH) exist and the same remains vacant, then they shall first be reverted to that respective parent category.
- (b) Thereafter, the conversion of SC, ST, OBC to General Category shall be done only during the Mop-up counselling. While converting the seats in Mop-up round, any unfilled seat reserved for ST category will be offered to SC category and vice versa and only after completing this exercise, the conversion of the reserved category seats to General Category shall be effected. However, any OBC vacant seat shall be directly converted to General Category.

- (c) All the candidates claiming seats in Defence Priority (I to IX) shall visit the University on the notified date and time. The University will call candidates priority wise for verification of documents and allotment of seats within the notified date and time.
- (d) Candidates are requested to refer to the tentative seats available for Mop-Up Counselling. All the candidates will be called accordingly to ensure that no seat remains vacant. However, the counselling shall stop as and when the seats are filled up.
- (e) Any category candidate, which have not been called and/or whose vacancy does not depict in the 'vacancy position' may attend the counselling as an unreserved category candidate and/or the vacancy may arise consequent to the conversion of categories during Mop-round of counselling.
- f) CUT-OFF percentile and score as per order/directions of Ministry of AYUSH.

IV. 
VI. REPORTING OF CANDIDATES TO THE ALLOTTED INSTITUTE/COLLEGE:
