**THE UNIVERSITY SHALL DECLARE CLOSURE OF COUNSELLING AS AND WHEN ALL THE VACANT SEATS ARE FILLED UP IN ORDER OF MERIT FROM AMONG THE REPORTED CANDIDATES.**

**IMPORTANT NOTE: ALL THE CONCERNED CANDIDATES ARE ADVISED TO STRICTLY ADHERE TO THE BELOW INSTRUCTIONS.**

- i) The admissions/allotment of seat shall be based only on the merit of NEET UG 2021 from among the registered students subject to verification of documents and fulfilment of eligibility for allotment of seat as per the regulations of the University/Statutory Body.
  - ii) It is mandatory for all the candidates to attend the counselling in person at the University Dwarka Campus along with their original documents and photocopies (for retaining in file).
  - iii) Candidates essentially shall produce the original certificates at the time of counselling/allotment of seat and in case he/she has taken admission somewhere else in programme other than BAMS/BHMS and deposited the documents, then he/she should submit a written proof from the concerned college/institution/ university for the same. **HOWEVER, THE SEAT ALLOTMENT SHALL BE STRICTLY AS PER THE NORMS OF M/O AYUSH REGARDING ELIGIBILITY TO PARTICIPATE IN COUNSELLING. ANY REGISTERED CANDIDATE WHOSE NAME APPEARS IN THE LIST OF IN-ELIGIBLE CANDIDATES UPLOADED BY AACCC, M/O AYUSH DATED 22.04.2022 SHALL BE NOT ELIGIBLE FOR ALLOTMENT OF SEAT IN BAMS & BHMS PROGRAM THROUGH COUNSELLING CONDUCTED BY GGSIP UNIVERSITY.**
  - iv) **CANDIDATES SHALL BE SUBMITTING AN UNDERTAKING OF NOT HAVING ADMITTED / JOINED ANY SEAT IN BAMS/BHMS CONSEQUENT TO THE CONDUCT OF COUNSELLINGS THROUGH AIQ/DEEMED/OR ANY OTHER STATE COUNSELLING ETC. AND SUCH CANDIDATES SHALL NOT BE GRANTED ANY SEAT IN THIS ROUND OF COUNSELLING. IN THE EVENT, THE CANDIDATE UNDERTAKING OR ANY OTHER DOCUMENT IS FOUND TO BE FALSE, THE ADMISSION OF CANDIDATE SHALL BE CANCELLED AT THAT STAGE OF THE PROGRAMME.**
