IMPORTANT NOTICE REGARDING AMENDMENT IN ELIGIBILITY CONDITIONS & ADMISSION CRITERIA FOR ADMISSION IN BCA PROGRAMME (CODE 114) FOR ACADEMIC SESSION 2022-23

It is for information of all the candidates, who are desirous to seek admission in BCA (Code 114) Programme during Academic Session 2022-23 that the Eligibility Conditions & Admission Criteria for admission in BCA Programme for Academic Session 2022-23 is mentioned as below:

"Pass in 12th Class of 10+2 of CBSE or equivalent with a minimum of 50% marks in aggregate* with pass in English (core or elective or functional). Mathematics or (Computer Science / Informatics Practice / Computer Applications / Multimedia & Web Technology / Data Management Application / Web Application as compulsory subject of non-vocational stream with 50 theory and 50 practical ratio. OR

Three year Diploma in a branch of Engineering from a polytechnic duly approved by All India Council for Technical Education and affiliated to a recognized examining body with a minimum of 50% marks in aggregate."

In addition to the above mentioned Eligibility Conditions & Admission Criteria for admission in BCA Programme for Academic Session 2022-23, the following shall also be considered for admission in BCA Programme for Academic Session 2022-23:

- (I) Applied Mathematics (Subject of 12th Class of CBSE) and Non-Vocational Stream with 70 theory and 30 practical ratio shall also be considered for admission in BCA Programme for Academic Session 2022-23.
- (II) Information Technology (Subject of 12th Class of CBSE) shall also be considered for admission in BCA Programme for Academic Session 2022-23.

The above changes/modifications are in addition to Eligibility Conditions & Admission Criteria already notified for admission in BCA Programme for Academic Session 2022-23.
