SCHEDULE FOR 'VERIFICATION OF DOCUMENTS' AND 'ALLOTMENT OF SEATS' FOR 02 SEATS OF MD (PAEDIATRICS) IN CHACHA NEHRU BAL CHIKITSALAYA FOR THE ACADEMIC SESSION 2022-23

This is in continuation to University Notification No. 252/2022 dated 01.10.2022 and 263/2022 dated 10.10.2022 regarding notice for Conduct of Physical Counselling for 02 seats of MD (Paediatrics) in Chacha Nehru Bal Chikitsalaya for the academic session 2022-23.

In this regard, all the candidates who submitted physical copy of their application duly filled with particulars as stated in the notification referred above for participation in Offline Counselling for allotment of 02 seats of MD (Paediatrics) under State/Institutional Quota, are hereby informed that the process of <u>'VERIFICATION OF DOCUMENTS' AND 'ALLOTMENT OF SEATS'</u> for the above stated programme i.e. MD (Paediatrics) at Chacha Nehru Bal Chikitsalaya is given as below:

Only the eligible candidates from among the list of applicants attached herewith as **Annexure** 'A', may appear for Verification of Documents and Allotment of Seats, as per the schedule given above.

Any candidate, who fails to appear in person on the scheduled date and time i.e. on 14.10.2022 at 11:00 A.M. for Verification of Documents and Allotment of Seats, shall not be entertained for the counselling process. At the time of counselling, the candidates shall provide a set of photocopies of documents along with the original documents.

The allotment of seat in the 1st round of Offline Counselling will be done on the basis of 200 roster point, subject to fulfilment of eligibility conditions by the candidates as laid down by the University. This year i.e. for 2022-23, the roster point shall start from 167. The specific roster point will be used to call the candidates of that particular category and all the seats at that point of time will be offered to the candidate. Since the roster points cannot be left blank, the conversion of seats of a category will be done during the first counselling itself. At the end of first counselling, if any seat remains vacant in any particular category for want of eligible candidate in that category, the seat will be converted as per the standard procedure of Govt. of India, which is as below:

"While converting the seats, any unfilled seats reserved for ST category will be offered to SC category and vice versa and only after completing this exercise, the conversion of the reserved category seats to general category shall be effected. The OBC seats shall be converted to General Category after exhausting the merit list of the OBC category. It will be ensured that conversion of any seat shall be done only when all the eligible candidates have been offered that seat."

Guidelines for Scheduled Caste, Scheduled Tribe Seats:

A Caste Certificate in the name of the applicant from a competent authority will have to be submitted at the time of Counselling.

Guidelines for OBC Seats admitted in "GGSIP University Quota" or "State Quota":

The certificate of OBC categories issued from the State of residence shall be acceptable, subject to the following conditions:

- i) The candidate should not fall under the creamy layer category as defined from time to time.
- ii) Only such candidates shall be eligible for reservation of the OBC category, whose caste is stated as OBC in the list notified by the Central Government (Union of India) or the Govt. of NCT of Delhi.
- iii) For the castes identified as OBC in the central list, certificate so issued from anywhere in the country may be admissible, and for the castes identified as OBC by the GNCTD, the certificates issued from GNCTD shall be admissible.
- iv) The date of issue of non-creamy layer OBC certificate should be after 31st March of the admission year.

A list of approved authorities to issue the SC, ST and OBC Certificates are as under:-

- 1. District Magistrate, Additional District Magistrate, Deputy Commissioner, Collector, Additional Deputy Commissioner, Deputy Collector, 1st Class Stipendiary Magistrate (not below the rank of 1st Class Stipendiary Magistrate), City Magistrate, Sub-Divisional Magistrate, Taluka Magistrate, Executive Magistrate and Extra Assistant Commissioner.
- 2. Chief Presidency Magistrate, Additional Chief Presidency Magistrate or Presidency Magistrate.
- 3. Revenue Officer not below the rank of Tehsildar.
- 4. Sub-Divisional Officer of the area where the candidate and/or his/her family normally resides.
- 5. Administrator, Secretary to the Administrator or the Development Officer (Lakshadweep & Minicoy Islands).

- 3. Admission Verification Form, Appendix 6 of Admission Brochure 2022-23 (to be duly filled by the candidate)
- 4. 10th class certificate for proof of date of birth

- 6. The compulsory rotatory internship completion certificate
- 7. Registration Certificate from Delhi Medical Council/State Medical Counselling
- 8. Character Certificate
- 9. Passport size photograph 04 nos.
- 10. Demand draft of Rs. 26,000/- (towards University share and Rs. 1000/- Non-Refundable Counselling Participation Fee) in favour of "Registrar, Guru Gobind Singh Indraprastha University", payable at 'New Delhi' to be deposited at the time of allotment of seat. Balance fee, if any, shall be paid directly at the allotted college after seeking admission.
- 11. Copy of Identity Card Passport/Aadhar/DL/Voter Card etc.

Joining at the allotted college: The candidates admitted through counselling conducted by the University on 14.10.2022 shall report to their allotted college/institute by 17.10.2022.

Withdrawal of admission:- The candidates after allotment of seat in 1st round of Offline Counselling will be allowed to withdraw their admission upto 03:00 p.m. of 26.10.2022. The candidate shall submit duly filled Appendix 11 of Admission Brochure 2022-23 enclosing alongwith the relevant documents at the time of submission of his/her request for withdrawal of admission.

<u>Procedure for conduct of 2nd round of Offline Counselling, if required</u>: The process for 2nd counselling shall be notified, if any vacancy arises due to withdrawal/non-joining of the allotted seat by the candidate within the stipulated date or otherwise. The process shall be in consonance with the guidelines as enshrined in the previous Admission Brochures of the University and in pursuance of the directions by Hon'ble High Court of Delhi in the Writ Petition (C) No. 3043/2014, titled "Dr. Sandeep Dhama vs State & Anr".
